


Giving by Mail



Personal Check

- ▶ Make your check payable to InterVarsity Christian Fellowship/ USA to ensure IRS tax credit.
- ▶ Each InterVarsity paper receipt comes with a “return portion” and a courtesy envelope. This return portion is encoded so that your next donation can be easily and accurately processed.
- ▶ You may also use a business reply envelope provided by an InterVarsity staff member. Be sure to indicate the ministry effort to which you want your gift applied.
- ▶ You can print the form from donate.intervarsity.org/mail-your-gift to mail with your check to the address on the form.
- ▶ Mailing checks to staff members instead of InterVarsity will delay processing of your check and may affect the month or year in which it is processed.
- ▶ The IRS requires that we issue a receipt to the person or business whose name is on the check.

Other Ways to Support Our Ministries



Stocks and Securities

Donating stocks or other securities you've owned more than 12 months can result in greater tax benefits than donating cash. We sell donated stock immediately for its market value on the day of the transfer through our broker at Charles Schwab.



Planned Giving

Gifts through your estate and gifts of assets such as real estate, life insurance, retirement accounts, and business interests can benefit both InterVarsity and your family.


Matching Gifts

Check if your employer has a matching gift program to maximize your donation.




Memorial & Tribute Gifts

You can give to InterVarsity in memory of a loved one or in honor of a special occasion. Please contact us for information about this.




Gifts-in-Kind

Make Your Gift Go Further



Although there are a number of ways to give, processing costs differ. In order to maximize your donation, we recommend giving online via electronic check. As you can see below, using your bank's bill pay system incurs extra fees.

Donations to InterVarsity are tax-deductible. Each time you donate, we will send you a tax receipt for your records. If you give online, we will send your receipt electronically. If you give by another method, we will mail a printed receipt to you. Each receipt shows your calendar year-to-date donation summary.
